Please note that River Music Experience (RME) will make efforts to supply earplugs for use during live recording sessions, but it is ultimately the responsibility of each student and/or participant to protect his/her own hearing. OSHA regulations for maximum sound exposure levels will be posted in the class, and a decimeter (device to measure loudness in dB) will be used to monitor sound levels in the studio. All students will receive audio safety training, including training in the use of a decimeter.

The RME will not be held responsible for hearing loss and, by signing this waiver, the student and/or participant releases River Music Experience (RME) from any insurance liability or responsibility for injuries or loss of hearing.
